COMPULSORY REPAYMENTS

Automatic repayments start when earning \$46,620 or higher

Repayment rate starts at 1%

Increases as your income increases

VOLUNTARY REPAYMENTS

Make any time regardless of income

Pay by **BPAY** or **credit card**

Helps in the long run
